### 2. Hazards Identification

**Emergency Overview:** WARNING! Causes serious eye irritation. Causes mild skin irritation. Hygroscopic. Keep out of reach of children. Avoid contact with skin, eyes and clothing. Harmful to aquatic life.

### 4. First Aid Measures

<b>Eye</b>	Possible eye irritation. Flush immediately with large amounts of water for at least 15 minutes. Eyelids should be held away from the eyeball to ensure thorough rinsing. Get immediate medical attention.
<b>Skin</b>	Possible skin irritation. Flush immediately with large amounts of water while removing contaminated clothing. Wash contaminated clothing before reuse.
<b>Inhalation</b>	Possible nasal irritation. Remove exposed person from source of exposure to fresh air.
<b>Ingestion</b>	Drink copious amounts of water. Seek medical attention. Do not induce vomiting unless directed by medical personnel.

**5. Fire Fighting Measures**

<b>Suitable Extinguishing Media</b>	Use dry chemical, foam, or carbon dioxide to extinguish fire. Water may be ineffective but should be used to cool fire-exposed containers, structures and to protect personnel. Use water to dilute spills and to flush them away from sources of ignition.

**6. Accidental Release Measures**

Use suitable safety equipment including nitrile gloves and safety glasses. Stop leak if possible to do so without risk.

Small spills clean up with sand or other noncombustible absorbent material and place into containers for later disposal. Large spills contain with dike ahead of spill for later disposal. (See Section 8) Flush with water to clean contaminated area. Do not flush to sewer or waterways. Prevent release to the environment if possible.

**7. Handling and Storage**

**Handling** Do not get in eyes, on skin or clothing. Do not breathe vapor or mists. Keep container closed. Use with adequate ventilation. Use good personal hygiene practices. Wash hands before eating, drinking or smoking. Remove contaminated clothing and clean before re-use.

**Storage** Store in tightly closed containers in cool, dry, well-ventilated area away from heat, sources of ignition and incompatibles. Ground lines and equipment to reduce possibility of static spark initiated fire. Store between 0 C (32 F) - 37.7 C (100 F). Best if stored out of direct sunlight. Keep container closed and upright when not in use. Protect container against physical damage.
