: **Distillates (petroleum), hydrotreated middle**: Middle distillates similar to the product represented by this MSDS have been associated with liver and kidney damage in subchronic (90-day) inhalation studies of male rats. In addition, certain middle distillates similar to this material have been associatted with liver damage in mice. The relevance of these findings to human health is unclear.
